1	Negative marking has been applied in the calculation of marks for each paper. The marks for each paper should be calculated using the formula below: "2 * Total Number of Correct Answers - 0.66 (1/3 of 02) * Total Number of Incorrect Answers" (Example: If 88 questions out of 100 are attempted, out of which 55 answers are correct & 33 answers are incorrect, then the total marks will be calculated as: (2 * 55) - (0.66 * 33) = 110 - 21.78 = 88.22)
2	The final score should be calculated as: Marks in Paper I + Marks in Paper II + Weightage Marks (If applicable)
3	OMR answer sheets have been evaluated based on the Booklet Set Code of the Question Booklet as marked (Bubbled) by the candidate in the OMR answer sheet. Evaluation has also been carried out according to the subject selected by the candidate at the time of application form submission.
4	Based on the final score, a merit-based state rank has been awarded to candidates who appeared in both papers Paper I and Paper II.
5	A separate category rank has also been awarded only to OBC, SC, and ST candidates as per their respective categories.
6	Answer keys are available on the official website of U.P. B.Ed. JEE 2026 conducted by Bundelkhand University, Jhansi.
7	If any uploaded document/certificate is found to be mismatched with the original document/certificate or is found invalid at the time of reporting to the University/Institute, the provisional admission of the candidate shall be cancelled. The candidate will be solely responsible for the same.
